### COPYRIGHT<sup>1</sup>, CONSENT AND RELEASE

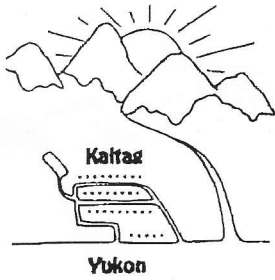
