AGREEMENT REGARDING YKSD BIOGRAPHY SERIES

1. Parties. Yvonne Yarber and Curt Madison (hereafter collectively called "Yarber and Madison"), on the one part and the University of Alaska Fairbanks, Alaska and Polar Regions Department, Rasmuson Library (hereafter referred to as "the University") on the second part.

2. Properties to be Conveyed. Yarber and Madison conveys to the University the following properties:

Audio interview tapes and manuscripts related to the Yukon-Koyukuk School District Biography Series, including an inventory of the tapes and manuscripts. These materials will collectively be given the title "Yarber/Madison Collection".

3. Restrictions. Yarber and Madison agree that any of the materials described in paragraph 2 above is given as an unrestricted gift and legal title and copyright to those materials shall be transferred to the University except as follows:

a. The materials shall be marked RESTRICTED for a period of 25 years from the date of this agreement.

b. During the restricted period, Yvonne Yarber and Curt Madison may have unlimited access to the materials during Archive hours in the Archives except as provided in paragraphs c and d below.

c. The Archives will provide copies of materials as requested by either Yarber or Madison for their research free of charge.

d. The Original materials may be removed from the Archives only for purposes of republishing or reprinting books in the Biography series.

e. The rights of Yvonne Yarber and Curt Madison under this agreement do not transfer to their heirs, assigns, successors in interest, or representatives unless expressly assigned or transferred in writing. The consent of the University is not required to transfer or assign the rights under this agreement.

f. Patrons may have access to the materials during the restricted 25 years only with the written permission of both Yvonne Yarber and Curt Madison.

4. This agreement may be modified only in writing signed by all the parties.
